STRAC REGIONAL EMERGENCY HEALTHCARE SYSTEMS CONFERENCE EXHIBITOR RULES AND FEES

Eligibility to Exhibit: Companies involved in providing education, supplies and services to the emergency healthcare profession (pharmaceuticals, instrumentations, practice management, computer software, ambulance equipment, hospital equipment) are encouraged to exhibit. All products must be directly related to practice of emergency healthcare and approved by STRAC in the sole and absolute discretion. Exhibitors shall not exhibit products or services other than those described in the application and approved by STRAC. All products and services exhibited at the STRAC Conference shall comply with FDA rules and regulations. An Exhibitor shall not in any manner directly or indirectly imply that a STRAC endorsement or approval of the exhibitor's product or service has been given merely because STRAC approved such product or service for display at the STRAC conference. The use of logos, seals of approval, trade-marks or other similar property rights that are in disuse may not be used in connection with any product or service or advertising material displayed or disseminated at the exhibit. Application deemed ineligible by STRAC will be returned with full payment.

(due to proximity of exhibitor tables to session rooms, we ask that tables are set up by 7:30am, prior to session start time)

Exhibit Hours: Wednesday, May 23rd 7:00am to 6:30pm (including Happy Hour in exhibitor area)

Thursday, May 24th 7:00am to 3:30pm

Dismantling: Thursday, May 24th 3:30pm to 4:30pm

<u>Exhibitor Representatives</u>: Exhibits must be staffed at all times during the exhibit hours. Additional and replacement badges will be available for \$25 each in advance or on site. Only exhibitors with badges will be permitted to enter the exhibit area during hours of installation and dismantling. No children under 16 years of age will be allowed in the exhibit area at any time.

<u>Failure to Occupy Space</u>: Any space not occupied by 6:00am May 23, 2019 will be forfeited by the exhibitor. This space may be reassigned or used by STRAC without refund, unless arrangements for delayed occupancy have received prior STRAC approval.

<u>Liability</u>: In the event that the conference is cancelled, postponed or relocated due to fire, strikes, government regulations, casualties, act of God or other causes beyond the control of the STRAC, the exhibitor waives any and all damages and claim for damages and agrees that the sole liability of STRAC shall be to return to each exhibitor the exhibitor's sponsorship payment.

<u>Special Restrictions</u>: Fire Hose cabinets and exits must be left accessible and in full view at all times. Decorations and displays must either be of nonflammable material or be treated by an approved fire prevention method.
